OFFICE MEMORANDUM

Subject: Continuance of the Grant of Lump sum Award beyond December, 2005 on passing Hindi Language, Hindi Typing and Hindi Stenography Examination under the Hindi Teaching Scheme through one's efforts.

The undersigned is directed to refer to this department's O.M No. 12013/1/2001-O.L.(Trg.), dated 4.9.2001 on the subject noted above and to convey the sanction of the President to the continuance of grant of Lump Sum Award to those Central Government employees/Officers who pass the Hindi Language, Hindi Typing and Hindi Stenography Examinations under the Hindi Teaching Scheme through one's own efforts, **beyond 31 December, 2005 upto 31 December, 2008.** The above extension of the period is applicable equally to the employees/Officers of offices located in all the three regions viz. "A", "B" and "C". The terms and conditions and the prescribed rates for grant of Lump Sum Award will be the same as specified in this Department's O.M. No. -12013/3/76 -O.L.(D), dated 21.05.1977; O.M. No.-12011/5/83-O.L (D), dated 29.10.1984 and O.M. No.-18/3/94-H.T.S.(HQ), dated 16.02.1995.

2. In so far as the employees serving in Indian Audit and Accounts Department are concerned, these orders issue with the concurrence of the Comptroller and Auditor General of India.
